13. Request to approve Ordinance 18-01 of Order & Notice to set the General Election for May 5, 2018, as well as appoint Election Judge and an Alternate Judge.

City Secretary explained the order and notice for General Election on the 1st Saturday in May, May 5th, and appoints the Election Judge and Alternate Judge. Also added a statement to allow City Secretary to change Election Judge and Alternate Judge if needed.

Commissioner Wimberley made a motion, seconded by Commissioner Cyprian, to approve Ordinance 18-01 of Order & Notice to set the General Election for May 5, 2018, as well as appoint Election Judge and an Alternate Judge. When the motion was put to vote, it prevailed as follows: Ayes: Cyprian, Blue and Wimberley. Nays: None. Absent: McKay, and Durham.

14. Request to approve Ordinance 18-02 revising Chapter 20, Article V, Section 20-81 - Trucking Routes.

Fire Chief Chaney stated we are trying to limit the trucks that are getting off the main roads onto our side residential streets. Reviewed the street changes listed in the Ordinance. This gives us the power of the law to issue citations to enforce.

Commissioner Blue made a motion, seconded by Commissioner Cyprian, to approve Ordinance 18-02 revising Chapter 20, Article V, Section 20-81 - Trucking Routes. When the motion was put to vote, it prevailed as follows: Ayes: Cyprian, Blue and Wimberley. Nays: None. Absent: McKay, and Durham.

15. Request to approve Ordinance 18-03 revising Chapter 13, Article IV - Accommodating Food Trucks.

Fire Chief Chaney stated we have been approached by an individual in regards to our fees being too high for permits for vendors. This will accommodate only food vendors at a lower permit and make us compatible with other cities.

Commissioner Wimberley made a motion, seconded by Commissioner Blue, to approve Ordinance 18-03 revising Chapter 13, Article IV - Accommodating Food Trucks. When the motion was put to vote, it prevailed as follows: Ayes: Cyprian, Blue and Wimberley. Nays: None. Absent: McKay, and Durham.

16. Request to approve Ordinance 18-04 revising Chapter 4 - Animals and Fowl.

Fire Chief Chaney stated we have adopted the state law and it doesn't cover completely the dangerous dogs. Dangerous animals that are jumping their fences and attacking other people and their animals. We've had people show animal attacks and a lady in a wheel chair that was attacked. This gives us more control in regards to a dangerous animal.

Commissioner Blue made a motion, seconded by Commissioner Wimberley, to approve Ordinance 18-04 revising Chapter 4 - Animals and Fowl. When the motion was put to vote, it prevailed as follows: Ayes: Cyprian, Blue and Wimberley. Nays: None. Absent: McKay, and Durham.

17. Request to approve the City’s Audit for Fiscal Year 2016-17.

Peter Morgan with GMS, reviewed the findings. He went over the audit revenues, expenditures and main fund balances. City Manager McCuistion stated all items in management letter have been addressed. We are doing a complete inventory on assets. New policies and procedures are now in place and additional training on software is scheduled for the Internal Controls.

Commissioner Wimberley made a motion, seconded by Commissioner Blue, to approve the City’s Audit for Fiscal Year 2016-17. When the motion was put to vote, it prevailed as follows: Ayes: Cyprian, Blue and Wimberley. Nays: None. Absent: McKay, and Durham.
